The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, Florida Statutes, Section 607, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is Forefront Web Design.Com, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence, effective upon the filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

The purpose is to engage in any and all business activities permitted under the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue Seven Thousand Five Hundred (7,500) shares of \$1.00 par value common stock.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The power to adopt, alter amend or repeal By-Laws shall be vested in the shareholders.


ARTICLE XII - AMENDMENT
