The name of this corporation is Malachi Consulting, Inc.

ARTICLE II. DURATION

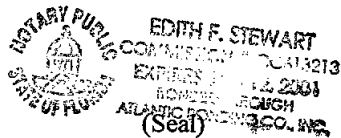
