#### ARTICLE I: NAME

The name of this corporation is MONROE COUNTY CHAMBER OF COMMERCE, INC. The mailing address of the corporation is 3045 N. Federal Hwy Suite 60, Ft. Lauderdale, FL 33306.

#### ARTICLE II: DURATION

This corporation shall have perpetual existence.

#### ARTICLE III: PURPOSE
