The undersigned, acting as incorporators of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation;

ARTICLE I

The name of the corporation is Goachim, Inc.

The corporation shall have authority to issue one hundred (100) shares of common stock, all of one class, one dollar (\$1) par value per share.


ARTICLE V
