ARTICLES OF DISSOLUTION*of***FARREN DAKIN DAIRY, INC.**

Pursuant to Section 607.1403, Florida Statutes, **Farren Dakin Dairy, Inc.**, a Florida corporation (the "**Corporation**"), submits the following Articles of Dissolution:

ARTICLE I

The name of the corporation is **Farren Dakin Dairy, Inc.** The document number for the Corporation is P99000107622.

ARTICLE II

The voluntary dissolution of the Corporation is authorized as of November 30, 2015.

ARTICLE III

The dissolution of the Corporation was approved by the shareholders of the Corporation holding a majority of the issued and outstanding stock of the Corporation entitled to vote.

ARTICLE IV

These Articles of Dissolution shall become effective on November 30, 2015, except that if these Articles are not filed by the Department of State of the State of Florida on or before such date, corporate dissolution shall become effective upon filing by the Department of State, and the Corporation shall be dissolved as of such date.

NOTICE OF DISSOLUTION

This Notice of Dissolution is submitted by **Farren Dakin Dairy, Inc.**, a Florida corporation (the "**Corporation**"), for resolution of payment of unknown claims against the Corporation as provided in Section 607.1407, Florida Statutes.

ARTICLE I
