The undersigned subscriber to these Articles of Incorporation, Kathleen Edwards, being a TALLAHASSEE, FLORIDA natural person competent to contract, hereby acknowledges and files these ARTICLES OF

INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

ARTICLE I

CORPORATE NAME

The name of this Corporation is STAR MEDIA GROUP, INC. The principal office and mailing address of the corporation is 800 Laurel Oak Drive, Suite 200, Naples, Florida 34108.

ARTICLE II

DURATION

The Corporation shall have perpetual existence, commencing upon January 1, 2000.

ARTICLE III

PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business.
