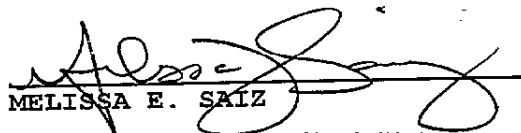
ARTICLE XI. AMENDMENTS
