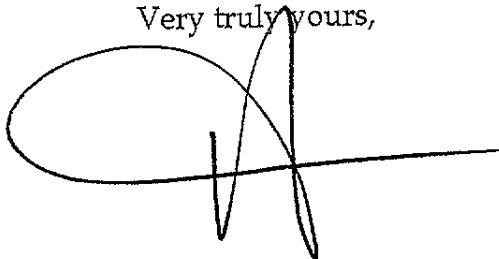

ARTICLES OF INCORPORATION

ARTICLE I – Name and Principal Place of Business

The name of this corporation is PRESTIGE ROOFING AND GUTTER, INC.,  
and its principal place of business is 1883 High Street, Longwood, Florida 32750.

ARTICLE II – Purpose

This corporation is organized for the purpose of providing roofing, gutters and the  
installation thereof or any other activity or business permitted under the laws of the  
United States and the State of Florida.

ARTICLE III – Capital Stock

This corporation is authorized to issue SEVENTY-FIVE HUNDRED (7,500)  
Shares, all one class, ONE and NO/100 (1.00) DOLLAR par value which shall be
