The name of this corporation is REVELATION PRESS, INC.

The corporation shall have a perpetual existence.

**INITIAL BOARD OF DIRECTORS**

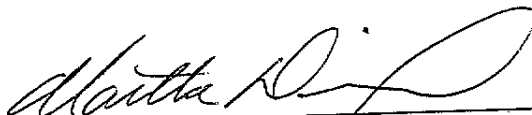

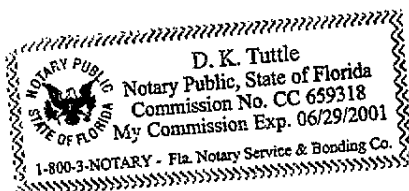
