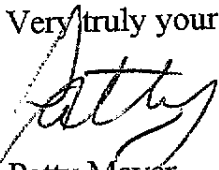

ARTICLE I

NAME

The name of this corporation is SAM'S RESIDENTIAL AND COMMERCIAL
MAINTENANCE, INC..

ARTICLE II

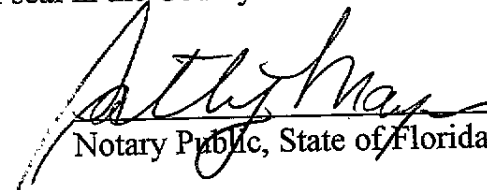

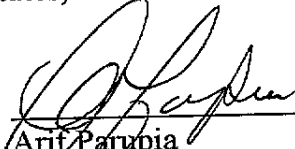
