ARTICLE I - NAME

The name of this corporation is: ***MOTOR RACING NETWORK, INC.***

ARTICLE II - DURATION

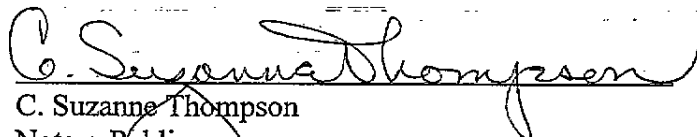

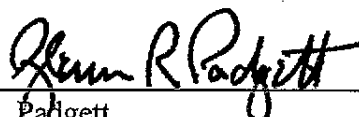
