In compliance with the requirements of E.S. Chapter 6077, the undersigned, DAVID L. SEGBERS, being a natural person, does hereby act as an Incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business Corporation.

ARTICLE I

The name of the Corporation is SFCom, Inc.
