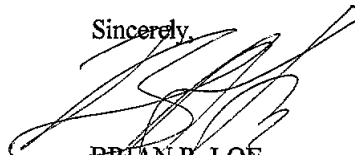

In compliance with the requirements of F.S. Chapter 607, the undersigned, DAVID L. SEGBERS, being a natural person, does hereby act as an Incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business Corporation.

ARTICLE I

The name of the Corporation is **SFCOM, Inc.**

ARTICLE II

The existence of the Corporation shall begin upon the filing and acceptance of these articles by the Secretary of State of the sovereign State of Florida and shall be perpetual.

ARTICLE III

The street address of the initial principal office of the corporation and the initial mailing address of the Corporation is also 321 Wilson Place, Drive, Sanford FL 32771.

ARTICLE IV

The maximum number of shares of stock that this company is authorized to issue and have outstanding at any one time is 1000 shares of voting common stock having a par value of Ten Dollars per share. Transfer of any share of this class of stock is subject to a right of first refusal of the other shareholders. All common shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share upon all matters on which shareholders have the right to vote.

ARTICLE V

The initial street address of the Corporation's registered office is 321 Wilson Place Drive, Sanford FL 32771. The initial registered agent for the Corporation at that address is DAVID L. SEGBERS. The board of directors may move the registered office and change the registered agent from time to time as it deems appropriate.

ARTICLE VI

The Corporation shall have two directors initially. The number of directors may be increased or diminished from time to time by the by-laws adopted by the shareholders but shall never be less than one.

ARTICLE VII

The names and addresses of the initial directors of this Corporation are:

The initial directors shall hold office until their successor(s) have been elected or appointed and qualified.

ARTICLE VIII

The name and address of the person signing these articles as Incorporator is DAVID L. SEGBERS, 321 Wilson Place Drive, Sanford FL 32771.

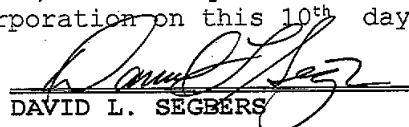
ARTICLE IX

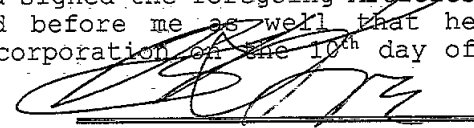
