On April 26, 2000 the above Corporation applied for an EIN with IRS. The original 2000 Uniform Business Report was filed with \$150 and "applied for" as the EIN. On May 26, 2000 you returned the Report as unfiled and requested that the Corporation supply you with their EIN.

Upon telephone inquiry with IRS, it was determined that no EIN had been issued. The SS-4 had been faxed to IRS. On June 10, 2000, another SS-4 was sent to IRS by fax. Telephone calls on the 16th and the 20th of June still produced no EIN and no explanation.

We telephoned Division of Corporations and spoke with Neil who instructed us to wait until we received the EIN. On October 10, 2000 we received confirmation of the EIN. About the same time the Corporation received notice of administrative dissolution.

The corporation has not conducted any business and has not issued shares of stock, however the incorporators do not want the Corporation administratively dissolved.

Since the 2000 Uniform Business Report was filed timely and that the only reason for failing to meet the reporting deadline was through errors attributable to the IRS, we request that the Division of Corporations waive the reinstatement fees and allow us to dissolve the Corporation correctiv.
