## ARTICLE I. NAME AND ADDRESS

The name of this corporation is Graylor Installation Corporation, and the address of the corporation shall be 5324 Bradbury Court, Tampa, Florida 33624.

## ARTICLE II. COMMENCEMENT OF CORPORATE EXISTENCE

The date when corporate existence shall commence is the date of subscription and acknowledgment of these Articles of Incorporation.

## ARTICLE III. DURATION

This corporation shall exist perpetually, commencing on the date of the subscription and acknowledgment of the Articles of Incorporation.

## ARTICLE IV. PURPOSE

This corporation is organized for the purpose of the transaction of any lawful business.

**ARTICLE V. CAPITAL STOCK**

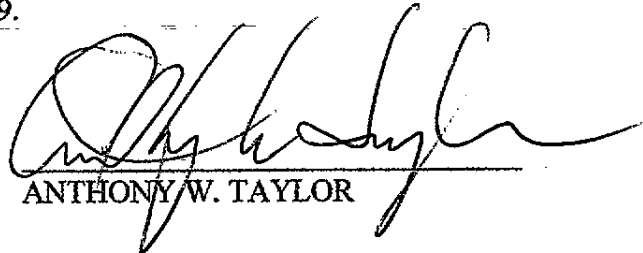
**ARTICLE X. INDEMNIFICATION**

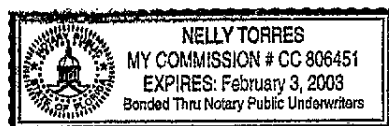

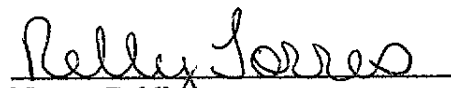

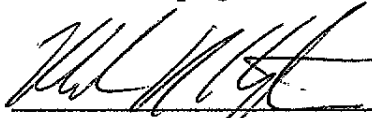
