The name of the corporation is **SURFBOOMERS, INC.**

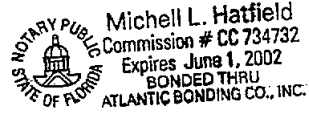


