The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida:

ARTICLE I. NAME AND PRINCIPAL ADDRESS OF CORPORATION

The name and address of the corporation is: **SAMOTHRACE AIR, INC.**, 2615 S. Crystal Lake Drive, Orlando, FL 32806-5001.

ARTICLE II. NATURE OF BUSINESS

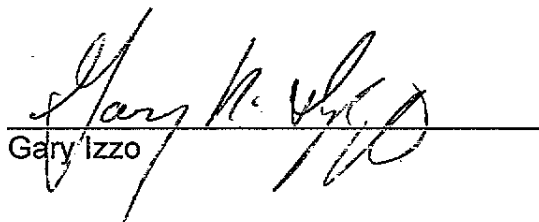

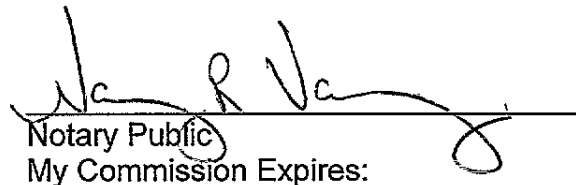

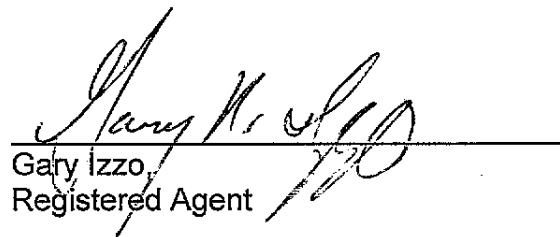
