ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I Name and Duration

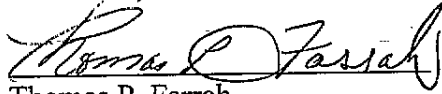

The power to adopt, amend or repeal bylaws for the management of this Corporation shall be vested in the Board Of Directors.

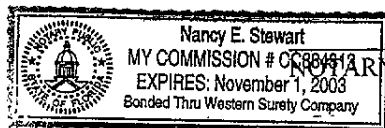

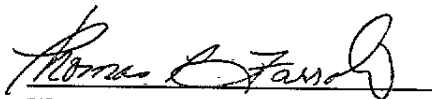
