

When applying for a state sales tax number we discovered that the corporation, Garden Street Depot, Inc. (P99000108671) we formed in 1999 was "inactive". We were told that a report was due on May 1 of each year after the incorporation papers were filed. We are just now completing construction of our business building and plan to open for business in June or July of 2001. Prior to beginning construction, our corporation "address" was a vacant lot. We never received any paperwork from the state regarding our corporation. This may be because the postman did not know what to do with mail addressed to a vacant lot.

We most definitely want to reinstate this corporation. I spoke to your representative on the phone last Friday, April 27, 2001. She told me to write a letter explaining that we did not receive any notice regarding reports due or any other correspondence from the state. She also told me to include a check for \$300.00, the fees for 2000 and 2001, and to request reinstatement without penalty. I plead with you to waive the penalty because we most definitely would have filed the appropriate paper work had we received notification. My husband and I are using our life savings to construct this building and start this business as our "retirement occupation". In hindsight, I guess we incorporated too soon but we were trying to be very conscientious and do things the way we thought they should be done. Again, I plead with you to accept the \$300.00 payment that we have enclosed and waive the penalty. I assure you that we will file the appropriate paperwork in the future.

As of two weeks ago, we are now receiving mail at 490 Garden Street, Titusville, FL 32796. I thank you for your consideration of this request and hope to hear from you soon.
