ARTICLE I. NAME

The name of this corporation shall be Charles J. Smith, P.A.

ARTICLE II. DURATION

This corporation shall have perpetual existence commencing on January 1, 2000.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of Real Estate sales, and anything pertaining to real estate professionals, as defined in Florida Statute Chapter 621.




