ARTICLES OF INCORPORATION

OF

J & R FRANKS PLUS, INC.

The undersigned, acting as Incorporator for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation for such Corporation.

ARTICLE I NAME

The name of the corporation is:

J & R FRANKS PLUS, INC.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III SHARES

The Corporation is authorized to issue 1,000 shares of common stock at \$1.00 par value each. Initially there will be only one class of stock. All of said stock shall be payable in cash, real or personal property, or labor in lieu of cash, at fair market value. The following shares shall be issued initially:

The Corporation elects to have preemptive rights so that the Shareholders of the Corporation have the right to acquire proportional amounts of the Corporation's unissued shares, upon the decision of the Board of Directors to issue them. The Corporation shall initially have one director. This number may be increased and/or decreased from time to time by majority vote of the Shareholders, but which may never be less than one. The initial director shall be JOSEPH R. DECARLO.

Additionally, the Corporation reserves the right to make an election as a Subchapter "S" Corporation agreeable to the provision of the U.S. Internal Revenue Code.
