The undersigned incorporator hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I NAME**

The name of this corporation is OLD WAY INVESTMENT, INC.

**ARTICLE II ADDRESS**

**ARTICLE III COMMENCEMENT OF CORPORATE EXISTENCE**
