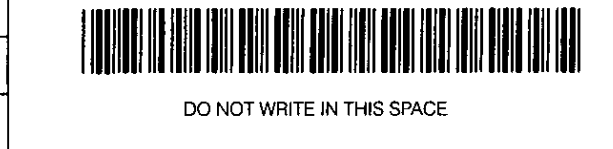

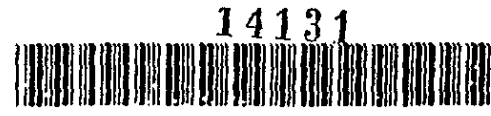


Gentlemen:
