ARTICLES OF INCORPORATION OF

STAFFORD & SEAMAN, P.A.

The undersigned subscribers to these Articles of Incorporation, being natural persons competent to contract, hereby form a professional corporation under and pursuant to the laws of the State of Florida, F.S. Chapter 621 and Chapter 607, providing for the formation, liability, rights, privileges and immunities of corporations for profit, and for that purpose, hereby certify, declare and set forth as follows, to wit:

ARTICLE I

NAME

The name of the corporation shall be: STAFFORD & SEAMAN, P.A.



ARTICLE II

GENERAL NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States the State of Florida, and the Florida Bar with regard to rendering and providing legal services, and other such activities as are allowed by law.
