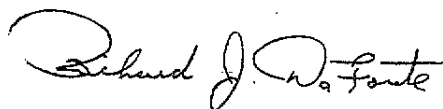

ARTICLE I

Name and Location

1.1. The name of the corporation is **JONZ, INC.** The mailing address of the corporation is 2622 Second Court, Palm Harbor, Florida 34684.

ARTICLE II

Duration

2.1 This corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation with the Department of State of Florida.

ARTICLE III

Purpose

3.1 This corporation is organized for the purpose of operating a convenience store and fuel station and transacting any and all lawful business.

ARTICLE IV

Capital Stock

4.1 This corporation is authorized to issue 7500 shares of stock of \$1.00 par value common stock.

Indemnification

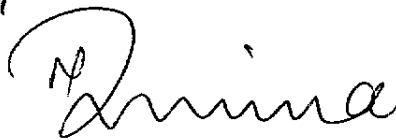

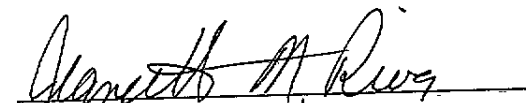
