I just recieved a "Notice of Administrative Dissolution or Revocation" form from your office.

On or about August 10, 2003 I recieved a *File Now* Notice from your office. Upon receipt of the *File Now* notice, I checked our records I found that we had filled out the form and returned it via mail with our check # 1267 for 150.00 June. A call to your office informing you of the above resulted in being told that, there was a back up in processing and to call back in a week. Needless to say , we neglected to call back as I figured you had gotten it and all was well.

Yesterday's arrival of the Dissolution Action prompted a frantic check of our bank statements and Am South Bank records . They both show the check has never cleared ! I have since voided it.
