#### ARTICLE I - NAME

The name of this corporation is: INTERNATIONAL LANDMARK MORTGAGE CORP.

, ARTICLE II - DURATION

This corporation is to exist prepetually. It shall commence its existence at the time of filing these Articles of Incorporation.
