SECOND AMENDMENT TO SECRETARY OF STATE TALLAHASSEE, FLORIDA FLA-CG I, INC.

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Business Corporation Act (1993), the undersigned corporation adopts the following Second Amendment to its Articles of Incorporation:
