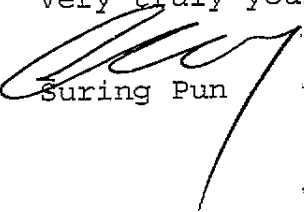

OF

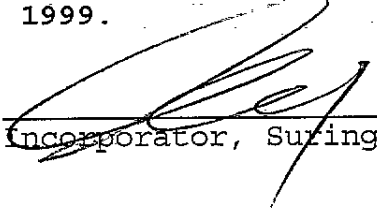

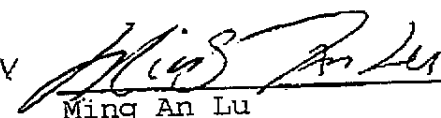
