ARTICLE I. NAME

The name of this corporation shall be William E. Morris, P.A.



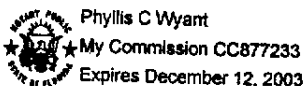
