#### ARTICLES OF INCORPORATION

We, the undersigned, subscribers to the Articles of Incorporation, natural persons, competent to contract, hereby form a corporation under the laws of the State of Florida.

# ARTICLE I

The name of the corporation shall be **MID-STAR CONSTRUCTION**, **INC.** Its principal place of business shall be 3733 Leeds Court, #103, Palm Harbor, Florida 34685.
