ARTICLE I. NAME

The name of this corporation shall be MOMENTUM BUILDERS, INC.

ARTICLE II. PRINCIPAL OFFICE

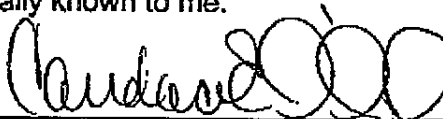
