***Articles of Incorporation
of

Article I – Name

The name of the corporation is: Deborah Smith, Psy.D, P.A.

Article II – Duration

This corporation shall exist perpetually.

Article III – Purpose

This corporation may engage in or transact any or all lawful activities or businesses specifically related to psychological counselling permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

Article IV – Capital Stock

This corporation is authorized to issue Seven Thousand Five Hundred (7,500) shares of One Dollar (\$1.00) par value common stock which shall be designated “Common Shares”.


Article IX – Initial Officers



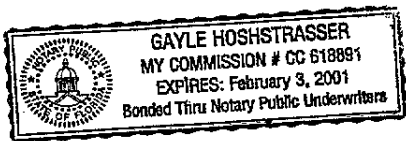


