## RC ACQUISITION CORP.

# ARTICLE I

The name of the corporation is RC ACQUISITION CORP. (the "Corporation" The effective date of the Articles shall be: December 17, 1999.

ARTICLE II

The address of the principal office and the mailing address of the Corporation is 1200 South Pine Island Road, Plantation, Florida 33324.

# ARTICLE III

This Corporation shall have authority to issue One Thousand (1,000) shares of Common Stock having a par value of \$0.01 per share.

## **ARTICLE IV**

The Corporation shall hold a special meeting of shareholders only:

- (1) On call of the Board of Directors or persons authorized to do so by the Corporation's Bylaws; or
- (2) If the holders of not less than 50 percent of all votes entitled to be cast on any issue proposed to be considered at the proposed special meeting sign, date, and deliver to the Corporation's secretary one or more written demands for the meeting describing the purpose or purposes for which it is to be held.

#### ARTICLE V

The street address of the Corporation's initial registered office is 1200 South Pine Island Road, City of Plantation, County of Broward, State of Florida 33324 and the name of its initial registered agent at such office is CT Corporation System.

#### <u>ARTICLE VI</u>

The Board of Directors of the Corporation shall consist of at least one director, with the exact number to be fixed from time to time in the manner provided in the Corporation's Bylaws.

#### ARTICLE VII

The name of the Incorporator is Connie Bryan and the address of the Incorporator is 1200 South Pine Island Road, Plantation, Florida 33324.

# ARTICLE VIII

This Corporation shall indemnify and shall advance expenses on behalf of its officers and directors to the fullest extent not prohibited by law in existence either now or hereafter.

IN WITNESS WHEREOF, the undersigned, being the Incorporator named above, for the purpose of forming a corporation pursuant to the Florida Business Corporation Act of the State of Florida has signed these Articles of Incorporation this 17th day of December, 1999.
