PRE-EMPTIVE RIGHTS

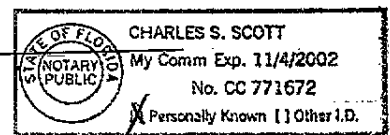


