ARTICLES OF INCORPORATION OF TROPICAL FRESH TILAPIA, INC.

The undersigned incorporator, for the purpose of forming a corporation for profit under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - CORPORATION NAME

The name of the corporation TROPICAL FRESH TILAPIA, INC. (the "Corporation")

ARTICLE II - PURPOSE
