ARTICLE ONE

The name of the corporation is **Accurate Tennis Courts, Inc.** The principal address of the corporation is: 711 N. Pine Island Road Suite 221 Plantation, Florida 33324.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

The aggregate number of shares which the corporation shall have authority to issue is **one thousand (1000) of no par value.**


ARTICLE FIVE
