
ARTICLE IX INCORPORATOR

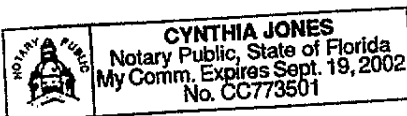
