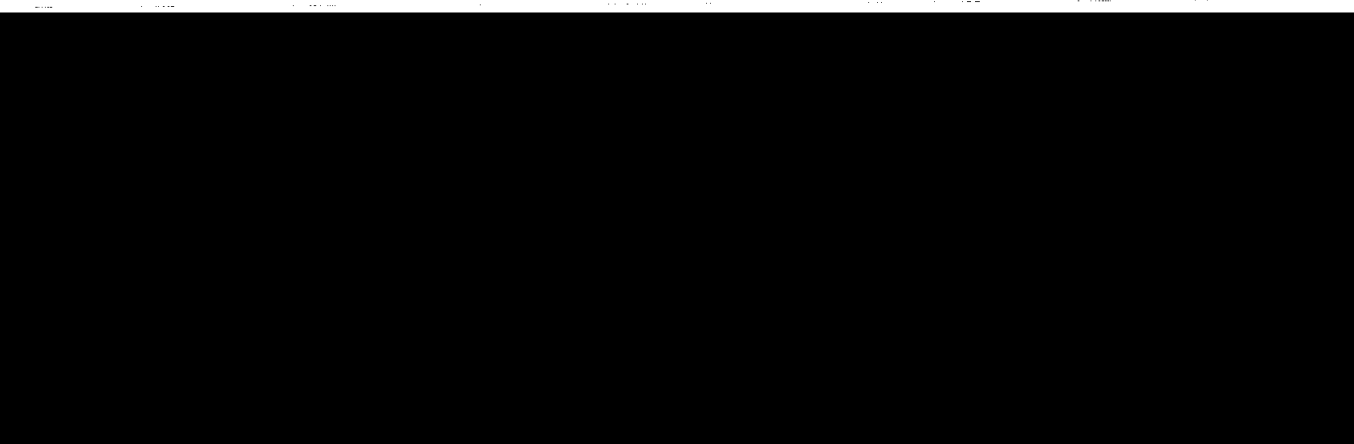
AMENDMENT

ARTICLE V

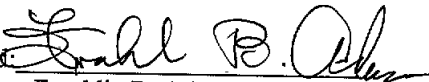
DURATION

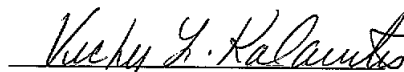
