Dear Sir or Madam;

I spoke with a representative of your division yesterday and he advised me to attach a letter with my UBR requesting that any penalty for late filing be waived.

I am new to business ownership and I had to dissolve the corporation I created in 1999 and register a new corporation in 2000. I never received a UBR for my previous corporation and I did not receive a UBR for the current corp. until this second notice showed up with a Sept.13 due date. There had been some mail disruption during this year resulting from an unfortunate change in my marital status.

I have enclosed the \$150.00 fee and request that any penalties that could apply be waived. I have no history of late filings and, with my business not providing any income at this point, additional costs would be an extreme hardship at this time. It would likely force me to dissolve this corporation.
