**ARTICLES OF INCORPORATION
OF
TOXICOLOGY RISK ASSESSMENT CONSULTING, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I - NAME

The name of the Corporation ("Corporation") is Toxicology Risk Assessment Consulting, Inc.

ARTICLE II - POWERS

The Corporation shall have the power to engage in any lawful activity which corporations may be organized under the Florida Business Corporation act

ARTICLE III - STREET ADDRESS OF PRINCIPAL OFFICE

ARTICLE IV - AUTHORIZED NUMBER OF SHARES

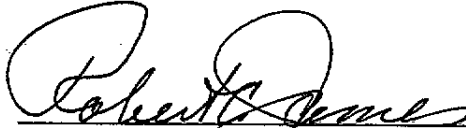

ARTICLE VIII - INDEMNIFICATION OF DIRECTORS, OFFICERS, EMPLOYEES AND AGENTS

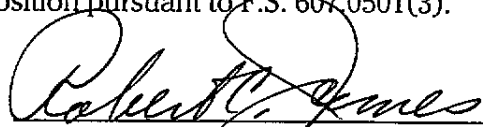
The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.
