Please find enclosed a copy of the 2003 Uniform Business Report for Historic Punta Gorda, Inc. and a check in the amount of \$150.00. We request that you reinstate this corporation upon receipt of this form and waive the fees for reinstatement.

As shown in the attached print out of the cash disbursements journal from March 7<sup>th</sup>, check number 1361 was issued in the amount of \$150.00.
