ARTICLES OF INCORPORATION OF DIHU DISTRIBUTORS CORPORATION

Pursuant to the provisions of the Florida General Corporation Act, the undersigned incorporator hereby makes, subscribes, acknowledges, and files these Articles of Incorporation.

ARTICLE I NAME

The name of this Corporation shall be DIHU DISTRIBUTORS CORPORATION.

ARTICLE II PRINCIPAL OFFICE

The principal office and mailing address of this Corporation shall be 8315 N.W. 68 Street, Miami, Florida 33166.

ARTICLE III NATURE OF BUSINESS

This Corporation is being formed to engage in any and all lawful business or activity permitted under the laws of the United States and the State of Florida.

ARTICLE IV TERM OF EXISTENCE

This Corporation shall have perpetual existence unless sooner dissolved in accordance with the laws of the State of Florida. The date on which corporate existence shall begin is the date on which these Articles of Incorporation are filed with the Secretary of State of the State of Florida.
