ARTICLES OF INCORPORATION OF DESIGNER'S ROW, INC.

The undersigned subscriber to these Articles of Incorporation, Christina E. Gavrilles, being a natural person competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

ARTICLE I

CORPORATE NAME

The name of this Corporation is DESIGNER'S ROW, INC. The principal office and mailing address of the corporation is 975 Imperial Golf Course Blvd., #111, Naples, Florida 34110.

ARTICLE II

DURATION

The Corporation shall have perpetual existence, commencing upon the filing of these articles with the Florida Secretary of State.


