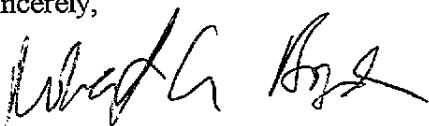

ARTICLES OF INCORPORATION OF ROBERT ANTHONY BOGDAN, P.A.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract and legally authorized to practice the profession of law in the State of Florida, hereby proceeds to form a professional corporation in accordance with the Florida Professional Corporation Act, and hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of this corporation is ROBERT ANTHONY BOGDAN, P.A.

ARTICLE II. PURPOSE AND NATURE OF BUSINESS

1. To engage in the practice of law as a professional service corporation and to provide services incident thereto.
2. To own property, enter into contracts and carry on any activity necessary or incidental to the accomplishment or furtherance of the purpose of this corporation.
3. The services of this corporation which consist of the practice of law shall be carried out only through officers, employees and agents who are active members of the Florida Bar in good standing and licensed in Florida to render the service of attorney.
4. To do everything necessary, proper or convenient for the accomplishment of any of the purposes herein set forth, and to do every other act incidental thereto which is not forbidden by the laws of the State of Florida, by the Rules of the Florida Bar Association or by the provisions of these Articles of Incorporation.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that the corporation is authorized to have outstanding at any one time is one hundred (100) shares having no par value per share. Such shares shall be of a single class of stock. None of the shares of the corporation may be issued to anyone other than an individual who is duly licenced to practice law in the State of Florida and is an active member of the Florida Bar in good standing.

ARTICLE IV. DURATION

The corporation shall commence January 1, 2000, and shall have perpetual existence.

ARTICLE V. ADDRESS AND AGENT

The street address of the principal and registered office of the corporation is 410 S.E. 1st Terrace, Pompano Beach, FL 33060-7108. The initial registered agent for service of process shall be Robert Anthony Bogdan. The Board of Directors may from time to time move the office to any other address in the State of Florida and change the registered agent.

ARTICLE VI. DIRECTORS

The corporation shall be managed by a Board of Directors of at least one (1) Director. No person shall serve as a Director of the corporation unless he or she is duly licensed to practice law in the State of Florida and is an active member of the Florida Bar in good standing. The Directors shall be elected by the shareholders of the corporation. The name and street address of each person who is to serve as a member of the initial Board of Directors is as follows: Robert Anthony Bogdan, Esq., 410 S.E. 1st Terrace, Pompano Beach, FL 33060-7108.

ARTICLE VII. SUBSCRIBERS

The names and addresses of the subscribers, who are incorporators of this corporation, each of whom is duly licensed in the State of Florida to practice law, are as follows: Robert Anthony Bogdan, Esq., 410 S.E. 1st Terrace, Pompano Beach, FL 33060-7108.

ARTICLE VIII. RESTRAINT ON ALIENATION

No shareholder may sell or transfer his or her shares in the corporation except to another individual who is eligible to be a shareholder of the corporation under Florida law.

ARTICLE IX. DISQUALIFICATION

If any officer, shareholder, agent or employee of the corporation who has been rendering professional service to the public for the corporation becomes legally disqualified to render such professional services within Florida or accepts employment that places restrictions or limitations upon his or her continued rendering of such professional services, then the corporation shall require him or her to comply with the Florida Service Corporation Act by severing all employment with and financial interests in the Corporation.

ARTICLE X. AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law.

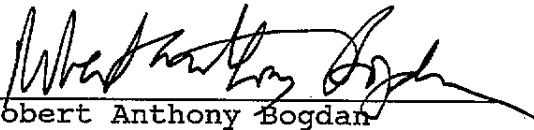
