#### ARTICLE I NAME

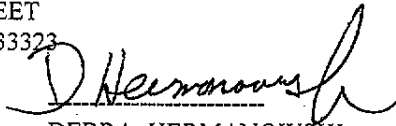

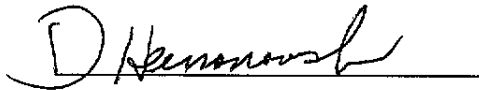
