

Articles of Incorporation of Darryl Wright and Associates, Inc.

The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME


**ARTICLE VI


