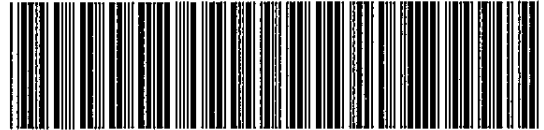

Pursuant to the provisions of §608.411, Florida Statutes, this corporation adopts the following Article of Amendment to its Articles of Incorporation:

FIRST: The number of shares of capital stock that the corporation is authorized to issue is 10,000 shares of common stock, having a par value of \$0.01 per share.

SECOND: Amendment adopted:

ARTICLE IV. - CAPITAL STOCK

The number of shares of capital stock that the corporation is authorized to issue is 20,000 shares of common stock, having a par value of \$0.01 per share.

THIRD: The dated of the above amendment's adoption is April 1, 2004.

FOURTH: Adoption of the above stated amendment was unanimously approved by the shareholders. The number of votes cast in favor of the amendment by the shareholders was sufficient for approval of said amendment.
