Upon receiving my first notice for my 2001 UBR on July 2, 2001, I was devastated to learn that the fee was now \$550.00 because I had missed the May 1st deadline. I am not one to pass responsibility onto others and I know it is technically my duty to oversee that this is paid on time but I am concerned because this was the first notice I have received concerning the 2001 UBR this year. Looking over past records everything has been in order and the \$150.00 fee has been paid properly when the past notices for prior years have come in.
