

The undersigned, acting as the incorporator of this Corporation under the provisions of Chapter 607 of the Florida Statutes, as amended, adopts the following Articles of Incorporation:

ARTICLE I: NAME OF CORPORATION

ARTICLE II: MAILING ADDRESS OF THE CORPORATION

The Corporation shall have one (1) director constituting as the initial Board of Director(s). The name and address of the initial Board of Directors of the Corporation are:



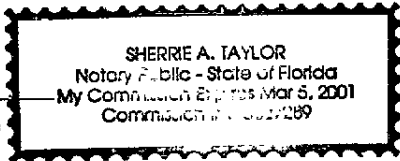
